Summary of Changes

• The Federal TD1 amount has had some further changes. The Basic was increased from \$12,229 to \$13,229 and if an employee's annual earning was above \$150,473 a proportion of that increase was taken away based on the annual earnings.

Now the government wants anyone that has further claims, i.e spousal, child, age, etc to complete a new TD1 form using the TD1-WS (work sheet).

The current program now works this way:

1) If the TD1 amount is zero, the system will use zero (used for employees who work for two different companies)

2) If the TD1 amount is greater than the Basic (\$13,229) then the programs expects the employee's TD1 was recalculated using the work sheet and the program will use the TD1 amount given.

3) If the TD1 amount entered is equal to the basic (\$13,229) and the employees annual earnings are less than \$150,473, the program will use the basic TD1 rate - or else the program will reduce the basic by the formula provided by CRA for employees earning over \$150,473.
